



MONROE STOPe SURVIVOR SERVICES

for those affected by domestic violence in Monroe County, TN

- ❖ **Safety Planning**
 - *For planning before/during/after vacating an abusive relationship to enhance the safety of survivors at home, at work, with kids, and in general.*
- ❖ **Civil Court Advocacy**
 - *Assistance with filing/understanding/using an Order of Protection*
- ❖ **Individualized Support Sessions for Survivors**
 - *One-on-one support for dv survivors seeking safety, justice, or healing*
 - *In-person, by Zoom, or by phone*
- ❖ **Group Support**
 - *Offered twice per week*
 - *Curriculum based for the purpose of identifying healthy vs. unhealthy relationships and to increase the safety and well-being of those seeking assistance*
- ❖ **Domestic Violence Community Education**
 - *Awareness campaigns/events*
 - *Training coordination/presentation for relevant service providers, local municipalities, youth-service agencies, elder adult serving organizations, and the general public*
 - *Healthy Relationships Plus Program; Evidence-based programs for youth*
- ❖ **Rape Aggression Defense Class (Self Defense for Women)**
- ❖ **Clothing Closet for STOPe clients**
- ❖ **Referrals & Resources**
 - *Relocation assistance & emergency shelter referrals*
 - *Resources for children exposed to domestic violence*
 - *Licensed counseling and/or therapy referrals*
 - *Referrals for legal assistance/resources*
 - *Substance abuse services/referrals*
 - *Prescription Drug Disposal*
 - *Supervised co-parenting/exchange program referrals*
- ❖ **Crisis Care Fund**
 - *Contingent on fund availability, specifically for needs within grant permissibility's, and based upon the outcome of the CCF Application board- approval process.*

*****Please note: The following services are not rendered by STOPe or the Monroe County Health Council: Shelter, financial assistance with housing for homeless, hotel vouchers, medical bills, court costs, attorney/legal fees, fuel/gift cards, anger management classes, parenting classes, batterers intervention, services necessary for client needs not originally deriving from a situation involving domestic violence, or any service deemed unsafe for STOPe staff/volunteers.**

STOPe reserves the right to refuse services based upon the determination of eligibility for our programming with consideration of the following criteria: the county of residence or the county where the situation occurred, the classification of violence being domestic, the absence of a conflict of interest or overlapping clientele (often due to competing orders), one having been identified as the individual victimized, needs that are within STOPe's scope of services, the available capacity for additional client cases, or the agency's ability to provide services in a safe manner for the advocate and survivor.
